Clearing Member Identification

Clearing Members must provide a valid SWIFT Distinguished Name (DN) and Business Identification Code (BIC) to utilise the Collateral Proposal (Colr.007), Collateral Proposal Response (Colr.008) and Collateral Management Cancellation Status (Colr.006) message. Members being registered for only the Triparty Collateral Status and Processing Advice (MT 558) or the Triparty Collateral and Exposure Statement (MT 569) need only provide a valid BIC.

SWIFT DNs must be formatted as follows: [cn=<name>,[ou=<name>]],o=<bic8>,o=swift

SWIFT BICs must be either 8 or 11 characters

LCH will use the SWIFT BIC: LCHLGB2LCOL when sending messages from CMS via SWIFT.
