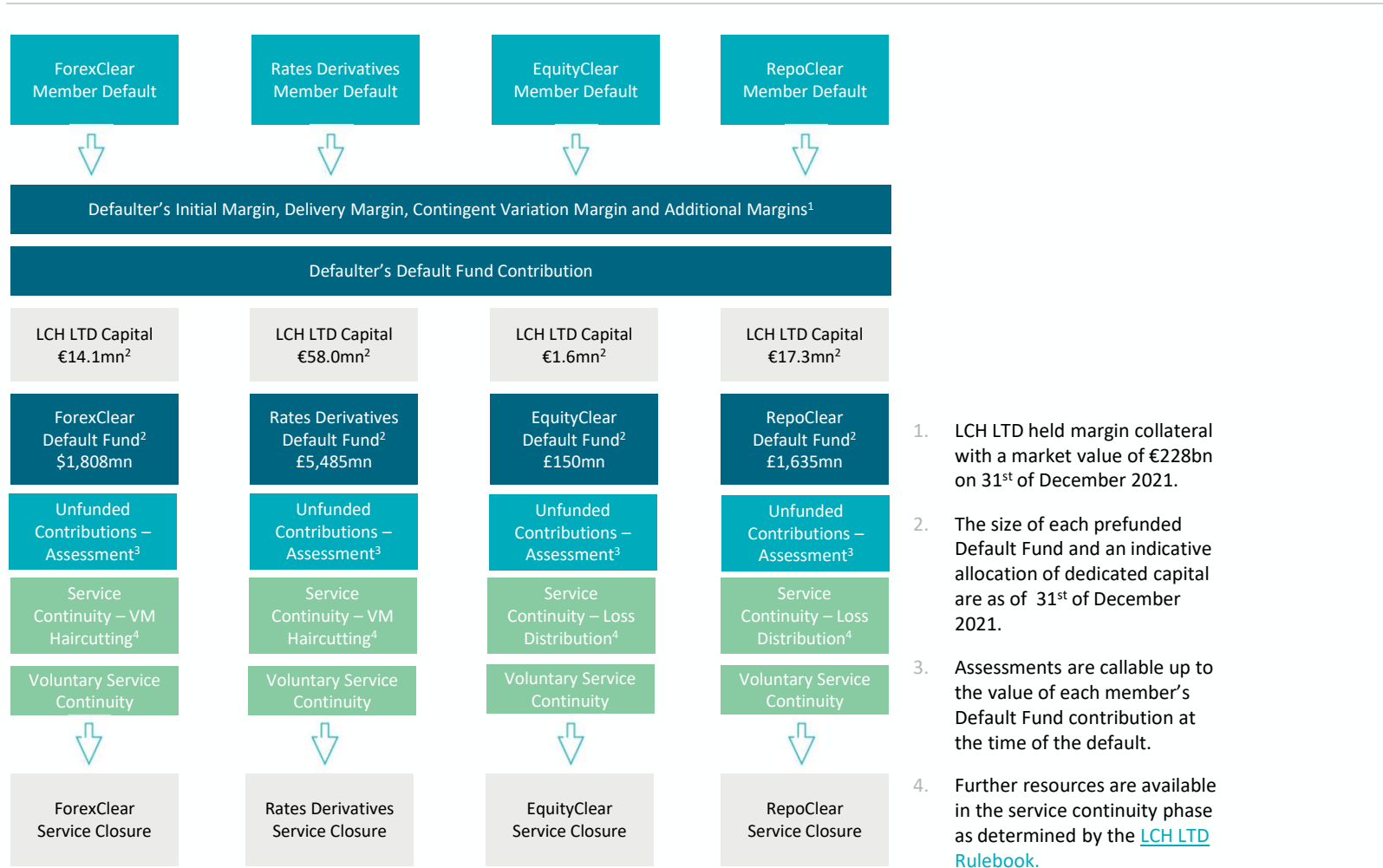


LCH LTD Default Waterfall
