1. LCH LTD held margin collateral with a market value of €243bn on 29<sup>th</sup> of April 2022.
2. The size of each prefunded Default Fund and an indicative allocation of dedicated capital are as of 29<sup>th</sup> of April 2022.
3. Assessments are callable up to the value of each member's Default Fund contribution at the time of the default.
