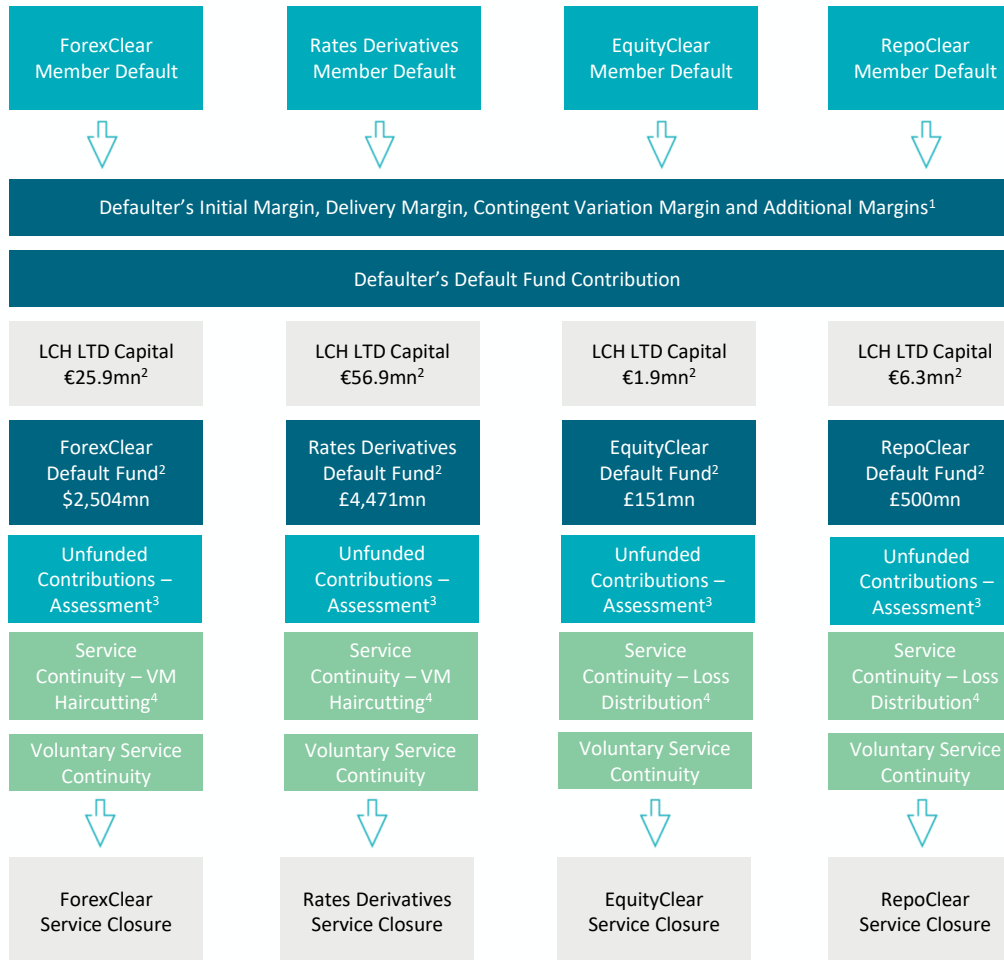


LCH LTD Default Waterfall



1. LCH LTD held margin collateral with a market value of €274bn on 31st of January 2023.
2. The size of each prefunded Default Fund and an indicative allocation of dedicated capital are as of 31st of January 2023.
