Dear Mr. Kirkpatrick:

LCH.Clearnet Limited ("LCH"), a derivatives clearing organization registered with the Commodity Futures Trading Commission (the "CFTC"), is submitting for self-certification, pursuant to CFTC regulation §40.6(a), a new Schedule of Securities Acceptable for Margin Cover Purposes (the "Schedule"). This change takes effect on or after 16 December 2016.

Part I: Explanation and Analysis

LCH proposes to implement this new Schedule following a review of haircuts applied to margin collateral. The list of acceptable securities remains unchanged.

The Schedule is attached hereto (as Appendix A) along with a confidential submission.

The Schedule will be notified via a circular to Clearing Members prior to the implementation date.

Part II: Description of Rule Changes

This submission does not require any changes to the LCH.Clearnet Rulebook.

Part III: Core Principle Compliance

LCH.Clearnet has concluded that compliance with the Core Principles will not be adversely impacted by this change, and in particular complies with Core Principles D and L.
