Cash Equity & Listed Derivatives Markets- Members Treasury Reports Review

Highlights

- Modifications of the Treasury report for clearing member active on several LCH SA business lines
- Testing period starting from **March 2018**
- Launch date: **April 2018**

Action: Members are requested to be prepared for testing and go-live on the target date

Dear Member,

LCH SA is pleased to announce the implementation of enhancements on the Treasury report displayed by LCH SA on a daily basis, via your usual access means (namely eCCW & LCAP connections).

- This change impacts clearing members acting on several LCH SA business lines namely "EquityClear & CommodityClear" on one side, and "Repoclear" on the other.
- LCH SA will provide one Treasury report per type of activity (i.e.: one specific to "EquityClear & CommodityClear" and another specific one for "Repoclear") instead of a unique treasury report as it is the case today.

- The format of the Treasury reports (both TXT and XML) remains unchanged but, the content of the Treasury report will be restricted to each related markets,
- As from April 2018, Clearing members active on the 3 business lines will benefit from a Treasury Report for “Repoclear” and a Treasury Report for “EquityClear & CommodityClear”. According to this split, the reports listed below will only display the information corresponding to each specific business line.
