Pursuant to CFTC regulation §40.6(a), LCH.Clearnet LLC, a derivatives clearing organization registered with the Commodity Futures Trading Commission (the "CFTC"), is submitting for self-certification changes to its fee structure for the LCH.Clearnet LLC's SwapClear US service as described in the attached circular.
